Part 1: General considerations for developing GFC Implementation Programmes

(Sections 1.5, 3.1)

GFC VI. Mechanisms to support implementation A. Implementation programmes


- The International Conference may adopt programmes to support the implementation of the Framework to achieve its "Strategic objectives and targets"
- Programmes should have their own focus and engage relevant sectors and stakeholders
- Programmes could include actions that stakeholders intend to initiate or contribute to meet the relevant targets
- Programmes should have mandates, terms of reference, workplans and/or other mechanisms
- Participation in Programmes open to all relevant stakeholders and sectors
- The International Conference may establish **ad hoc working groups** to provide guidance and mobilize engagement.

ICCM 5 Resolution V/8 on "Implementation arrangements"

- Urges Governments, intergovernmental organizations, civil society and the private sector to comprehensively implement the GFC
- Invites the IOMC, governments, and stakeholders "to collaborate on, and develop proposals for implementation programmes (...)"
- Proposals should address "respective mandates, terms of reference, workplans and other mechanisms"
- Possible adoption at the next International Conference (2026) should not delay immediate stakeholder action
- Reference to the value and dimensions of integrated chemicals and waste management

V/8: Areas of work for Implementation Programmes to be considered

Three dimensions of integrated chemicals and waste management



Potential common features and value-added of GFC implementation programmes

- Awareness raising: Raising awareness of the GFC and targets by reaching out to relevant stakeholders
- Multi-stakeholder engagement: Engaging all GFC stakeholders, even if Programme targets a specific stakeholder group
- Knowledge: Identifying good practices and fostering knowledge-sharing
- Coordination and collaboration: Strengthening coordination and collaboration of stakeholder actions
- Guidance: Taking stock of guidance and technical support and filling gaps, as appropriate
- Project development: Technical support for developing project proposals
- Finance: Helping to access financial and technical support (e.g. though matchmaking/twinning initiatives)
- Analysis: Assessing progress to reach respective targets, identify challenges and foster solutions

Possible common elements of GFC Programme TORs

- 1. Relevant GFC targets
- 2. Stakeholders encouraged to engage
- 3. Type of programmatic action, projects and activities encouraged
- 4. Linkages with other GFC implementation programmes and activities
- 5. Criteria for stakeholder participation
- 6. Governance arrangements (multi-stakeholder)
- 7. Knowledge-sharing (e.g. on front runner action, coordination, challenges, etc.)
- 8. Implementing mechanism/vehicles (e.g. alliance, partnerships, communities of practice)
- 9. Financing and resources considerations
- 10. Reporting back to the International Conference

Indicative questions to assess programme success

Has a Programme been able to.....

- reach out to all, and engage new stakeholders?
- catalyze new implementing activities by stakeholders?
- identify and widely share good implementation practices?
- coordinate and create synergies in implementation activities?
- provide access to and/or mobilize additional resources for implementation?
- identify implementation bottlenecks and solutions?

Part 2: Strengthening integrated national chemicals legislation and institutional capacities

(Section 2.1)

Proposed Programme 1: Strengthening integrated national chemicals legislation and institutional capacities

Proposed focus

- GFC Strategic Objective A and Target A1 (legal frameworks and institutional capacity)
- Other targets: A2, A3, A5, A6, A7, B1, B2, B3, B4, B6, D2, D4, D7, E2, E3, E5, E6

Initial activities (under development and consideration)

- Concept paper on "Options for developing basic national chemicals legislation for industrial and consumer product chemicals"
- Development of legislative modules / building blocks to fill gaps and address emerging topics of interest
 - **Possible topics**: mutual acceptance of data, hazard classifications and assessment methods; streamlined risk assessment/management decision-making for industrial and consumer product chemicals; incentives for green and sustainable chemistry innovation; and cost recovery and sustainability of national systems.
- IOMC/GFC Survey to identify countries interested and committed to strengthen their national chemicals legislation and institutional capacities
- Identification of countries and organizations available to provide support ("match-making")
- Development and dissemination of a tool to support countries in self assessing their national chemicals legislation and institutional capacities ("baseline and needs analysis")
- Provide technical support to interested countries in developing project proposals

Programme 1:Consultative process/activities and development of draft Terms of Reference and Workplan

2024 Activities

- Development of a discussion document on a "GFC Implementation Programme on strengthening integrated national chemicals legislation and institutional capacities"; 3rd Q 2024
- Webinar on an "Implementation Programme on integrated national chemicals management legislation and institutional capacities" (planned)

2025 Activities

Back-to-back global workshops, 1st/2nd Q 2025

- "Strengthening legislation and institutional capacities for industrial chemicals and consumer product chemicals"
- "Developing a GFC Implementation Programme on strengthening integrated national chemicals legislation and institutional capacities: Mandate, TORs and Workplan"
- Submission of Inf Note to OEWG, June 2025

- Are the proposed initial activities valuable? What is missing?
- What can be done to raise awareness on the topic in developing countries?
- How can capacity development activities of IOMC POs, bilateral actors, NGOs and industry be identified and coordinated?

Part 3: Strengthening economic and industry sector engagement and action

(Section 2.2)

Proposed Programme 2: Strengthening economic and industry sector engagement and action

Proposed focus

- GFC Strategic Objective D: Targets D6 & D3 (Sustainable chemical and waste management strategies in major economic and industry sectors & Private and finance sector strategies)
- Other Targets: A3, A4, A7, B1, B2, B3, B4, B5, B6, B7, D1, D4, D7, E2, E3, E6



Initial activities (under development and consideration)

- IOMC industry sector outreach survey, July 2024
- Fostering early engagement with selected industry sectors (i.e. Health Care, Textiles, Electronics, Construction, Pharmaceuticals, Finance and Investment)
- Overall guidance to support development of chemicals and waste strategies in economic and industry sectors (D 6)
- Identification of possible additional topics for guidance development (e.g. chemical footprint assessment, transparency on chemical information in the value chain)

Programme 2: Consultative process/activities and development of draft Terms of Reference and workplan

2024 Activities

- Development of a separate discussion document on an GFC Implementation Programme on "Strengthening economic and industry sector engagement and action"; 3rd Q 2024
- Webinar on an Implementation Programme on GFC Implementation Programme on "Strengthening economic and industry sector engagement and action" (planned)

2025 Activities

Back-to-back global workshops, 1st/2nd Q 2025

- "Developing a GFC Implementation Programme on strengthening economic and industry sector engagement and action: Mandate, TORs, workplan and strategy development guidance (Target D6)"
- "Identifying opportunities to engage institutional investors and strengthening disclosure & reporting standards for GFC implementation (Target D3)
- Submission of Inf Note to OEWG, June 2025

Discussion questions

- Are the proposed initial activities valuable? What is missing?
- How can chemicals and waste management strategies developed by industry (Target D6) inform disclosure standards and investment choices of the financial sector/investors (Target D3)?
- How can momentum be nurtured in specific industry sectors to develop sector implementation programmes (health care, electronics, textile, private finance, etc.)
- Umbrella programme (guidance, knowledge-sharing, oversight) comprised of industry sector programmes?

Part 4: Linking with sustainable development decision-making processes

(Section 2.3)

Programme 3: Linking chemicals and waste management with sustainable development decision-making processes

Proposed focus

- Strategic Objective E of the GFC and Target E 6 *
- Other relevant Targets: A3, A6, A7, B4, B5, C1, D1, D2, D3, D4, D5, D6, D7, E1, E2

Initial activities (under preparation and consideration)

Development of short primers on specific SD topics and targets

Possible Topics: national development planning; climate change; biodiversity; education; innovation; health care; and MEAs

 Exploring opportunities to develop a possible Programme on "Chemicals and Climate Change"





^{*} By 2030, stakeholders identify and strengthen, linkages between chemicals and waste management and other key policies (e.g. climate change, biodiversity, human rights protection, primary health care)

Programme 3: Consultative process/activities and development of draft Terms of Reference and workplan

2024 Activities

Dedicated follow-up webinar (planned)

2025 Activities

- Development of a discussion document on "Possible GFC Implementation Programme on integrating chemicals management in sustainable development decision-making processes"
- Inf document for OEWG, June 2025 to elicit feedback towards developing a mandate, TORs, and workplan

Discussion questions

- How can momentum be nurtured to foster programmatic work on specific topics (e.g. development planning, climate change, education)
- Are there stakeholder champions ready to engage in the development of a Programme/workstream on the above topics?

 - > Economic and industry sector engagement and action (including institutional investors/finance sector), 1st/2nd Q 2025
- Information document(s) for the OEWG, June 2025
- Refinement of draft mandates, draft TORs and workplans, 3rd/4th Q 2025
- Discussion on and possible adoption at the next Internation Conference, end of 2026
